Reclaiming for the Future

In Colorado, our “mine” permits are really “reclamation” permits. After all the natural resources have been extracted from a mine site, it must be reclaimed for a beneficial end-use. Reclamation uses can include plans for wildlife areas, rangeland, cropland, residential, recreational, and industrial uses.

Star - West Lake water storage/access roads



Two L. G. Everist, Inc. mine sites in Colorado have been reclaimed and are now ready for their end-use as water storage reservoirs. The combined water storage capacities of **Star Water Resource** and **Rinn Valley Resource** have the potential to annually sustain 7200 households of an ever-growing population. Reclamation of these sites was rigorous and included constructing compacted clay liners, finishing the slopes at 3:1, vegetating surrounding areas with native grasses, and constructing access roads for maintenance.

En Colorado, nuestros permisos de “mina” son realmente permisos de “recuperación”. Después de que todos los recursos naturales se han extraído de un sitio de la mina, debe ser reclamado para un uso final beneficioso. Los usos de recuperación pueden incluir planes para áreas de vida silvestre, pastizales, tierras de cultivo, usos residenciales, recreativos e industriales.

Star - West Lake water storage/access roads



Dos sitios de mina de L. G. Everist, Inc. en Colorado han sido recuperados y ahora están listos para su uso final como depósitos de almacenamiento de agua. Las capacidades combinadas de almacenamiento de agua de Star Water Resource y Rinn Valley Resource tienen el potencial de sostener anualmente 7200 hogares de una población cada vez mayor. La recuperación de estos sitios fue rigurosa e incluyó la construcción de revestimientos de arcilla compactada, acabando las pendientes a 3: 1, vegetando las áreas circundantes con pastos nativos y construyendo vías de acceso para el mantenimiento.
